Candidates will be required to bring all the requisite documents mentioned above for Document Verification at the time of interview failing which their candidature shall out rightly be rejected. No additional time shall be given to produce the original documents.

Candidates must bring with them any one Photo Identity Proof such as PAN Card/ Passport/ Driving License/ Voter's Card/ Bank Passbook with photograph/ Aadhar card or E-Aadhar with a photograph /Identity card issued by Employer in original along with a photo copy of the same. Candidates without valid ID proof

- will not be permitted to appear for the interview. If the identity of any candidate in any way appears to be doubtful, he/she will not be allowed to appear for the interview.
3. Candidates are being called to appear in the interview provisionally on the basis of documents furnished by them with their Application Form as to their Age, Qualification as on cut-of date etc. as per the advertised eligibility criteria.
  4. It may please be noted that, in case, any of the particulars furnished by a candidate in his/her application, under reference, are found to be incorrect/ not meeting the requisite specifications or not supported by requisite documents, his/her candidature would liable to be rejected forthwith and will not be allowed to appear for the interview and no TA will be paid.
