NOTES:

- 1. Candidates have been shortlisted for the Skill Test in order of merit, in the ratio of 1:5 (i.e., five candidates for one post), from among those who have secured a minimum of 50% marks in the OMR-based test. For SC/ST/ExSM/PwBD candidates, minimum qualifying marks in OMR based test for shortlisting for Skill Test is 40% (after providing 10 % relaxation in OMR based test marks) against the reserved posts only.
- 2. All those candidates who have secured marks equal to the last shortlisted candidate after applying the 1:5 ratio, category-wise, have also been shortlisted for the Skill Test.
- 3. The above candidates are provisionally shortlisted and their candidature is subject to verification of documents. The documents of shortlisted candidates shall be checked on the day of Skill Test and only such candidates shall be allowed to appear in the Skill Test whose documents are found to be in order and who meet the eligibility criteria as mentioned in the advertisement.
- 4. Skill Test will be of qualifying nature only. The final merit list will be prepared solely on the basis of the marks obtained in the OMR-based test, from among those candidates who qualify in the Skill Test.
- 5. All above shortlisted candidates have already been intimated about the Skill Test vide email dated 09.08.2025.
